**Recruitment for the post of Deputy Director-cum-Deputy Secretary at Association of Municipalities and Development Authorities, New Delhi.**



5. 'Canvassing' in any form shall disqualify the candidate.

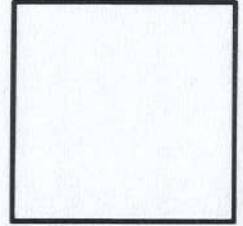
