3. The general terms & conditions for short listing of Agency / Firm are as follows.
 - a) The initial engagement will be for duration of 12 months from the date of contract. The period of engagement may be extended thereafter and will be at the discretion of AMDA, subject to fulfillment of the laid-out criteria.
 - b) The engagement of Agency will not attract any financial commitment from AMDA until & unless the Manpower is not deployed in AMDA.
 - c) The Agency/Firm office should be located within NCR area.
 - d) The Agency / Firm must have the following valid registration & documents.
 - (i) Registration of PF (ii) Registration of ESIC (iii) Registration of Current Labour License (iv) Registration of PAN/TAN (v) GST Registration etc.
 - e) The Agency/Firm shall abide by and comply with all the relevant laws and statutory requirements covered under various Labour Acts, Minimum Wages Act, EPF, ESI/Leaves etc. with regard to the personnel engaged and deployed by the firm.
 - f) The Agency/Firm should have at least three (3) years experience in similar nature work with Govt. office / PSUs / Corporate of repute.
 - g) The Agency/Firm Annual Financial Turnover during the last 3 Years of the previous financial year, should be more than Rs. 10.00 Lakh.
