VACANCY NOTICE

Recruitment for the post of Accounts Officer at Association of Municipalities and Development Authorities, New Delhi

Association of Municipalities and Development Authorities (AMDA) founded in 1983 and registered under the Societies Registration Act 1860 with the objective to share matters of mutual interest of members comprising of Municipal Authorities and Development Authorities. AMDA provides an impetus for the adoption of techniques and methods conducive to the improvement in the efficiency of Municipal Authorities and Development Authorities by conducting training programs.

Applications are invited from eligible candidates for filling up **one post** of **Accounts Officer** at Association of Municipalities and Development Authorities, New Delhi. The appointment will be on short term contract basis for upto 2 years which may be extendable upon the performance of the incumbent.

Conditions

- Suitable candidates will be shortlisted, based on their eligibility /experience in the relevant field and shall be called for Interview.
- Interview detail shall be communicated to the Candidates in advance and Candidates from Outstation have to make their own arrangements for travel and stay.
- The candidates selected for respective positions in AMDA may need to join on short period notice.

- d. The candidate who will be appointed under contract shall deposit the security in the form of cash equivalent to the salary of notice period as mentioned in the appointment order, which shall be kept in AMDA on a refundable basis without interest. This is to avoid sudden exit, ensure adherence to contractual condition and to provide enough time to AMDA for arranging new replacement.

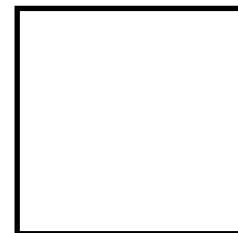
Incomplete applications received after due date shall not be accepted. AMDA will not be responsible for non-receipt / late receipt of the application / any communication due to postal delay or any other reason.
