- 1 Eligibility Criteria for Participating in this Tender are subject to provisions in the Tender Document. Participation in this Tender Process is open to all such bidders who fulfill the 'Eligibility', technical compliance and Additional Terms and Conditions (ATCs).
- 1.2 The bidder should meet the following eligibility criteria as of the date of this bid submission and should continue to meet these till the award of the contract. The bidder shall be required to declare fulfilment of Eligibility Criteria on its letterhead as under:
 - I. Not stand declared ineligible/ blacklisted/ banned/ debarred by the Procuring Organization or its Ministry/ Department from participation in its Tender Processes. 100 Rs stamp paper declaration with Notarized undertaking to submit of same.
 - II. Not be convicted (within three years preceding the last date of bid submission) or stand declared ineligible/ suspended/ blacklisted/ banned/ debarred by appropriate agencies of Government of India from participation in Tender Processes of all of its entities, (on letterhead)
- III. Not have a conflict of interest, which substantially affects fair competition. The prices quoted should be competitive and without adopting any unfair/ unethical/ anti-competitive means. No attempt should be made to induce any other bidder to submit or not to submit an offer for restricting competition (on letterhead).
- 1.3 The bidder shall submit a valid certification from OEM declaration.
- 1.4 The bidder/OEM should have similar experience in of supply, installations and commissioning in last 3 years of one work with 80% of project estimated cost or 2 works pf 50% of the project estimated cost. Valid proof of the same to be attached.
- 1.5 Bidder/OEM should have registration with GST and has a PAN card.
- 1.6 The bidder will submit proof of business registration.
- 1.7 Joint Ventures are not Permitted.
- 1.8 Balance sheet for previous three financial years with ITR of bidder duly verified/vetted by CA.
- 1.9 The bidder must submit the MAF (Manufacturer's Authorization Form) from respective OEMs participating in Bid.
- 1.10 The bidder should submit the Escalation matrix for service & Compliance.
- 1.11 OEM/bidder has to submit detail of Service centre in Delhi of the items supplied.
- 1.12 All the equipment/Item quoted in BID are of latest technology and High Tech which is integrated with advance version.

1.13 Purchase Preference Policies of the Government: the Procuring Entity reserves its right to grant preferences to eligible Bidders under various Government Policies/ directives (policies relating to Make in India; MSME; Start-ups etc.).

BIDDER SCOPE OF WORK

- 1. Supply, installation testing and commissioning as per Technical Specifications as per document for Set up Video conferencing system with audio video presentation system /switching control system / Audio and Video Integration/ sound control system/Video conference control system as a Board room conference system Project.
- 2. Technical Specifications prepared by AMDA has been drafted for bidding purpose. However, it is the responsibility of the bidder to do the site survey (at his cost) and submit proposal that fulfil functional & performance requirements, an analysis of the functional and performance requirements of this specification and/or site surveys, design, and engineering may lead the bidders to conclude that additional items are required that are not specifically mentioned in this specification.
- 2.1 The bidder shall depute Engineer immediately for commissioning upon receipt of Materials.

3. DOCUMENTATION:

3.1. One set of documentation (hard copy), which shall include general description of the equipment, operating instruction manual, detailed manual, configuration and installation manual, trouble shooting and maintenance manual, information regarding operating ranges, safety instructions, default settings etc. should be furnished along with the supply of the materials for all the system/ sub-system and equipment.

4. QUALITY PLAN, INSPECTION AND TESTING:

- 4.1. The successful bidder shall submit quality plan/ test procedures for all the items to be supplied and also for installation and commissioning and testing. The quality plan shall set out the practices, procedures, relevant standards and acceptance level for all components of the system and for integrated system operation. This plan shall be finalized after mutual discussions and approved by AMDA.
- 4.2. Site inspection: After all the material are received at the site along with test certify cates as per approved quality plan, AMDA will inspect this equipment for verifying compliance as per order specifications and that there is no damage during transportation.

5. SYSTEM DESIGN AND ENGINEERING:

Successful bidder is advised to make a detailed report of implementation Plan of project. Detail engineering has to be done and the best feasible design has to be implemented by the Bidder. Design and selection of the equipment's should be such that it should meet requirements of long-term trouble-free operation with highest degree of reliability and performance. The system design, equipment selection and system implementation should also concentrate on flexibility of future expansion and maintainability without much hassle.

6. DESIGN IMPROVEMENTS AND FUTURE EXPANSION:

The system implementation has to be done in such way, to give flexibility of system design improvements and future expansion. This expansion shall be conveniently achievable by modular expansion without doing any major modification or substitution of already installed equipment and without interrupting existing operations. All civil work is in Scope of Bidder.

7. SITC of Video conference System:

During SITC of the said system, expenditure towards any additional furniture repair and adjustments required with the existing furniture shall be borne by the successful bidder.

- 10.2 Bidder shall depute Engineer to attend the fault at site upon intimation by AMDA over phone or through e-mail.
